#### From the President:

Dear Members and Friends:

I regret that due to a variety of reasons, there has not been a newsletter since before our Budapest meeting in July 1997. I trust that the current letter will bring you up to date. We were very pleased by the attendance at the Budapest colloquium on "Periodization: An Intercultural Perspective", 4-6 July 1997, which was cosponsored by the Institute of History at the Hungarian Academy of Science and hosted by the Europa Institute. I would like to express my special gratitude to Dr. Attila Pók of the Hungarian Academy and Mr. Song-Ho Ha (Buffalo) for their marvellous work in organizing the conference. This was the most cosmopolitan colloquium this Commission has held, both in terms of the scope of the topics under discussion and the broad geographic distribution of the participants. Some of the papers from the conference will be published in an issue of Storia della Storiografia specifically devoted to the issue of periodization.

Meetings of the Bureau of the Commission were held on 6 July 1997 in conjunction with the colloquium in Budapest and on 13 June 1998, at the Centre Marc Bloch in Berlin. A major part of the discussions at these meetings centered around the role which the Commission might play in preparing the 19th International Congress of the Historical Sciences, to be held 6-13 August 2000 in Oslo. Our commission recommended to the CISH International Committee of the Historical Sciences) the topic "The Uses and Misuses of History. The Responsibility of the

Historians." This topic was accepted by the CISH at the meeting of its General Assembly in Spoleto, Italy, in September 1997 as one of the three all-day major theme panels in Oslo. Edoardo Tortarolo represented the commission in Spoleto. I was subsequently asked by the CISH to organize this panel and serve as its moderator. Prof. François Bédarida, the general secretary of the CISH and general program chairman for the Oslo congress, will act as commentator. The panel has now been completed and includes participants from all six continents. Although the focus is on the twentieth century, attention will also be given to the function of history in earlier times. Members of the Bureau of the Commission have also been active in other panels of the world congress. Jörn Rüsen is convenor of the major theme perspectives of global history; Masayuki Sato a co-organizer of the panel on historical time. Rolf Torstendahl and Irmline Veit-Brause are organizing the panel on historiography in the twentieth century. There have been a number of international conferences in the history and theory of historiography which have been of interest to the Commission. Since 1994 "Chinese and Comparative Historiography from a Perspective" project, sponsored by the Chiang Chingkuo Foundation for International Scholarly Exchanges based in Taiwan, has held a number of conferences in Germany, North America and East Asia under the direction of Thomas Lee of City University of New York, in which members of our bureau, including Jörn Rüsen, Richard Vann, and myself, have been actively involved. Within the context of this project, a colloquium on "Turning

Historical Thought. **Points** 1n Intercultural Approach" will be held at the University at Buffalo on 19-20 August 1999. Also within this context was a conference held in Essen in June 1988, Identity," "Crisis, Trauma, approached historical thinking in China comparatively. Edoardo Tortarolo organized a conference "Universal History Now: Necessity or Chimera" held in February 1998. Leipzig in Several conferences are being planned in preparation for the Oslo conference. The Norwegian organizing committee planning a conference for European secondary school teachers on historical teaching in secondary schools to be held in Oslo 28 June-1 July 1999; the Second International Conference "History Under Debate" will be held July 14-18, 1999, in Santiago de Compostela, Spain. Other preparatory conferences are being planned for Budapest in April, 1999, Upsala, August 1999, and Tokyo, 1999, but the dates have not yet been finalized.

The next meeting of the Bureau will in Poznan, 9-12 March 2000, in preparation for the Oslo congress. At Oslo we shall also have to elect a new slate of officers and bureau members. You should think about persons who can be recruited for these positions. It would be desirable to improve our geographic, age, and gender distribution. I shall not be a candidate for re-election but hope to continue as an active

member of the Commission.

A committee headed by Richard Vann is organizing our Commission's panel for Oslo 2000. Below you will find a report by the committee.

## Minutes of the ICHTH Bureau Meeting

Europa Institute, Budapest, 5 July 1997

- 1. The Bureau approves the minutes of the last meeting in Gottingen in 1996. The minutes of this meeting have been published in the Newsletter.
- 2. I. Veit-Brause reports on the problems caused by the mailing list which has not been updated. The President calls the attention to the fact that the mailing list of the Newsletter should be updated by the national representatives in the Commission. His suggestion is that Sanchez Marcos will be responsible for Spain, Portugal and Latin America; Topolski for Poland, Tortarolo for Italy. Siegel stresses that the newsletter should have a nice, more attractive format. The commission discusses various practical problems which would arise from a more sophisticated format and the possibility that the Commission has a Web page on the Internet. The President suggests that Qingjia Edward Wang will be responsible of it. The commission approves. Veit-Brause will still be responsible for the newsletter.
- 3. a. The President reports on his correspondence with Prof. Bedarida, who has accepted the proposal of the Commission regarding the topic to be discussed in Oslo in 2000. The President reads to all members page 47 of the Bullettin of the Commission where "The responsibility of the historian" is mentioned among the subjects for Oslo 2000.
- b. In Spoleto the commission will have two delegates and one vote. As the President will be unable to attend the commission will be represented by Edoardo Tortarolo and Bianca Valota.
- c. Thomas Lee reports extensively on the activities of the Chinese Historiographical Commission which he directs. Wang plans a congress on "Turning points in historical thinking" to be held in the USA in 1999.

Tortarolo reports on the conference "Universal History Now: Necessicity or Chimera?" to be held in Leipzig in February 1998. Valota reports on a conference on "What's Central europe? Methods, Problems, Perspectives" to be held in Milan in October 1998 and suggests that the next meeting of the Bureau will take place on that occasion. A decision will be make after consultation via e-mail.

- 4. There is a lively discussion among all members of the Bureau concerning the grand thème suggested for Oslo 2000 and the speakers who should be invited. There general sentiment that Commission's representatives should make a strong case for the Grand thème during the general assembly in Spoleto. Pók insists on the visibility of the Commission in Oslo as the main goal of the Commission's participation in the International Congress of the Historical Sciences. Sato reports on his proposal to organise a panel in Oslo on comparative history and periodization. Ankersmit suggests that should be topic for the seminar of the commission in Oslo. Torstendahl proposes "Journalism and Professionaalism in Historical Writing" Novick is for "The Status of the Historian as a Cultural Personality in the 20th Century". The President suggests a new formulation: "The Status of the Historian as a Cultural Figure at the End of the 20th Century". Veit-Brause suggests that an email discussion will deal with this in the next months.
- 5. The Treasurer's report is read: In 1996 39 persons payed the membership fees, in 1996 they were 33, and 16 of them subscribed to Storia della Storiografia as well. 24 payed with a credit card, 8 by cheque, 5 in cash. In 1996 we payed 650 CHF (US\$445) for the institutional membership fee of our Concerning 1997 we have received so far 16 membership fees for this year and 8 subscriptions to the journal. 9 members have payed by credit card and 3 by cheque. At present we have in our current account US\$1320,82, excluding the income from the subscriptions. We can easily pay our institutional membership fee for 1997 to the CISH. I expect the financial position of the

ICHTH to continue improving, thanks to the generous help of all the members of the Bureau and of the ICHTH.

#### 2. Newsletter:

The President: The Newsletter for 1998 has not yet come out. The latest issue 1s dated March 1997. The problems about distribution especially in North America should be solved now. Technical solutions such as e-mail distribution have been discussed. The Bureau expects that the Bullettin 1998 will be out soon.

- 3. The President reports on his correspondence with Prof. Bedarida and gives further information on Oslo 2000. Torstendahl reports that in Oslo there will be a half day devoted to historiography in the 20th century; this means that the Bureau will be there careful in choosing the subject for its own session.
- 4. The Secretary general reads the report on the activity on 1997. The text is as follows:

1997 has been a extremely busy and important year for the Commission for the History and Theory of Historiography. Two important events took place involving the Commission. In July most of the members of the Bureau participated in the conference on Periodization in History and Historiography: An Intercultural Comparison, generously sponsored by the Hungarian Academy of Sciences and the Europa Institute Budapest. It is essential that the papers reflected the main object of the Commission, i.e. to support a broad intercultural discourse on historiography. Participants from Korea and Japan contributed interesting insights into the problem of periodization and led to exhilarating debates. The cosmopolitan atmosphere during the Budapest conference was an appropriate basis to the Oslo conference in the year 2000. The President of the Commission, Prof. Iggers, charged with the demanding task of organising the major event of the CISH. This is not exactly what the Commission

expected as a careful reading of the minutes of the Göttingen meeting in 1996 makes clear, when it was proposed that the Commission volunteers to organise the grand thème The responsability of the Historian. The preparation for Oslo 2000 has kept all members of the Bureau busy. In September 1998 I was charged by the President to join the assembly of the delegates of the different national and of affiliated commissions the commissions of the CISH in Spoleto. As I reported in an e-mail message shortly after the assembly, the Commission played a significant role in its development. It was officially made known that one of the grand thèmes that will be attended by all participants has been given over to our President. It is worth noting that the topic concerning the responsibility historian has been suggested by the Bureau to the steering committee of the CISH and that this suggestion was the issue of a extended and open discussion among the members of the Commission.

We still have to determine the topic of our session in Oslo. We can choose between the following topics: "Professionalization De-professionaalization of Historians in the 20th Century", "The Status of the Historian as a Cultural Personality in the 20th Century." "Historians in Exile and under Repression in the 20th Century". It is advisable that at the meeting in Berlin next June a decision is made in order to arrange a suitable list of speakers. (To be published in Newsletter 1998)

5. The treasurer Sanchez Marcos reports on the financial situation of 1997. The commission has 28 members in good standing. The budget has an asset of 421 US\$. The President reports on the papers read in Budapest in 1997 and on the problems about their publication.

6. Rüsen reports on the research project based in Essen on historical thinking in China: Krisis-Trauma-Identität.

The President reports a conference on the

The President reports a conference on the same subject to be held in Buffalo, August 22-29, 1999. A lively discussion follows on the opportunities offered by these

conferences. There is a general agreement that the Bureau meets again in 1999: the discussion is on the most suitable place. Several possibilities are debated: in Buffalo in August, in Budapest at the Soros Foundation, in Poznan. An extended consultation will settle the matter.

A long discussion is devoted to the session of the Commission in Oslo. The existing proposals are read and discussed. Rüsen proposes that a workshop deals with the topic Historians and the future. The President proposes: Historiography leading 21th century. Segal: New technologies and consequences for the historical craft in the future. Mommsen: Anticipations of the future in the major ideologies. Veit-Brause: Historian as a public intellectual. Rüsen suggests a second subject: Catastrophe and historiography. This suggestions is finally accepted. A committee, formed by Tortarolo, Vann and charged Veit-Brause, is with organisation of a workshop on Catastrophe and historiography.

Call for papers for the Theory and Historiography Network

The Third European Social Science History Conference will be held in the town of Amsterdam, on 12 - 15 April 2000.

The ESSHC aims at bringing together scholars interested in explaining historical phenomena using interdisciplinary approaches to the study of the past. The conference is characterized by a lively

exchange in many small groups, rather than by formal plenary sessions. It is organised in a large number of networks which cover a certain topic (e.g. criminal justice, family, inequality). The Theory Historiography network is interested in proposals for panels (consisting of three papers and a comment) as well as individual papers related to the issues of theory and historiography. There is a special interest in comparative approaches.

The conference fee will be dfl. 300 (at present this is about US \$ 150). The deadline for sending in panel and paper proposals (maximum of 400 words) is 30

April 1999.

#### CONFERENCE REPORTS

1. The general secretary reports on the conference in Leipzig 1998. The text follows.

On 12-13 February 1998 a conference on World History Today - Chimera or Necessity? has taken place in Leipzig, Zentrum für Höhere Studien, Universität The participants have Leipzig. François Hartog (Writing Universal History and the Age of Antiquity), Helmut Zedelmaier (The Writing of Universal History in Early Modern Times), Reba Soffer (Catholicism and Historiography in the 19th and 20th Centuries), Jürgen Osterhammel (Anglo-American Models and Styles of World History in the 20th Century), Alberto Piazza (Genetics and History), Kurt Nowak (Religion in History), Giovanni Filoramo (Religion and World History), Hans-Heinrich Nolte (Russia and World History), Quingjia Edward Wang (World History in China), Sebastian Conrad (What is Time in Japan? The Dilemma of World History from a Post-Colonial Perspective), Adam Jones (Africa in World History), Ewa Domanska (Universal History and Postmodernism), Johan Galtung (Micro and Macro and Historiography), Present Giuseppe Ricuperati (Universal History versus World History?).

The conference was meant to break new ground and to focus on a topic which have disregarded by most academic historians in recent decades. Therefore many papers have dealt the tradition of world history and universal history has were written in the past and on the future of what is now called world or global history. The growing interest in world history is connected with the globalisation that is becoming an everyday experience for more and more people. Many participants have partial prevailing how the perspectives on world history have been in the national cultures in the West as well as in the East. In order to meet the need for orientation in the social space-time it is important to discuss how to write a world history which is deeply universal. The proceedings will be published in Storia della Storiografia.

Remapping the German Past: Grand Narrative, Causality, and Postmodernism

CONFERENCE AT THE GERMAN HISTORICAL INSTITUTE, DECEMBER 4-7, 1997

The conference brought together about 30 historians from Germany, Great Britain, and the United States in order to discuss the epistemological consequences, which resulted from new approaches contemporary historiography and made different impacts on the historical scholarship in Germany and the United States. Linking specific theoretical concepts with empirical research, the meeting surveyed the common cognitive principles of historical understanding and methods of historical research. The conference aimed also to investigate the advantages and theoretical limitations of different approaches and their transformation in historical practice by comparing modern epistemological principles to postmodern concepts. The theoretical sessions. therefore, focused on three historical epochs in German history; namely, the German Empire, the Weimar Republic, and the events of 1989/90. But in contrast to academic debates that have been taking place in Germany over the past two decades, the sessions did not center around interpretations specific of developments in German history, but rather around three systematic concepts paritcular: the advantages and limits of grand narrative," the problem "causality," and the issue of "objectivity, memory, and historical meaning."

2. Science and Historical Discipline in a Transcultural Perspective, 1850-1950

WORKSHOP ORGANIZED BY THE GERMAN HISTORICAL INSTITUTES IN LONDON AND WASHINGTON, WASHINGTON, OCTOBER 4-5, 1997

This workshop tried to break new ground in historiography with its intention to spur interest in such an international and transcultural perspective on the history of the historical discipline. Its purpose was to look back at the origins, the mechanics, and the results of scientific exchanges between

different cultures, to compare the processes of professionalization of the historical discipline within different cultures, and to define the workings of the international relationship between Western and non-Western scientific communities. The 22 participants who attended the meeting represent four continents and teach in seven countries. They gave papers on African, European, American, Japanese, Chinese, Latin-American, and Indian historiography. The program focused primarily on a perspective of non-Western Western science. The introductory session theoretical concentrated on methodological problems, followed by three sessions that took Great Britain, France, and Germany as a starting point. By using these countries, where the national historical disciplines were most advanced in the Western world at the end of the nineteenth century, two different issues were discussed: the possibilities and the limits of a structural comparison of academic historical disciplines different cultures on the one hand, and their relationship, perceptions, and influences on the other.

Report on the Second European Social Science History Conference, Network Theory and Historiography, 5-7 March, Amsterdam, the Netherlands.

The European Social Science History Conference - supported by the International Institute of Social History in Amsterdam - gathered for the second time in Amsterdam in March 1998. Over a thousand historians and historically minded social scientists from all over the world presented papers and discussed interdisciplinary problems varying from fields such as the history of Antiquity over migration and elites to ethnicity, nations and gender.

In the Network Theory and Historiography 8 panels were organized concentrating on various topics. Two panels on 'Hidden histories and new mythologies in post-communist East Central Europe' focussed on the problems with and the problematic uses of history in post-communist Eastern Europe. Most papers of these two panels

will be published as a theme-issue by the journal for history and anthropology, Focaal. Two other panels were devoted to `Perspectives and problems of comparative historiography.' The first panel with papers by Georg Iggers, Sebastian Conrad and Joern Ruesen discussed the problems of comparative intercultural history both at a theoretical level (Ruesen) and at a concrete level as manifested in Chinese and (Iggers Japanese historiography Conrad). The second panel focussed on comparative international historiography. Juergen Kocka discussed the Sonderwegdebate in German historiography, followed by Daniel Levy's comparison of Israeli and German historiography. Richard Bosworth discussed the Sonderweg of postwar historiography in Italian comparative perspective. Four of the papers of these 2 panels have been published in a 'Forum on comparative historiography' in the 1st. 1999-issue of History and Theory, others in a volume edited by Peter Burke.

History, the panel modernity, Veit-Brause, postmodernity,' Irmline Christopher Lloyd and Dennis Smith discussed theoretical problems related to modernity issue of versus postmodernity, varying from the rationality (Veit-Brause) to the of historicism rationality of evolutionary theory (Lloyd) and Zygmunt Baumann's diagnosis of (post)modernity (Smith). The panel `Longterm perspectives on globalizationí'(Mike Hanagan and Nico Wilterdink) highlighted the pros and cons of long-term analyses in history and the panel History, sociology narrativity' (Mark Bevir, Munslow and Aviezer Tucker) tackled the classical problem of narrative explanation in history. The last panel 'History and the representation of the Holocaust' (Thomas Sandkuehler, Robert-Jan van Pelt and Conny Kristel) dealt with the problem how to represent the Holocaust in history.

Most discussions were lively and productive. They backup the expectation that the next ESSH-conference in Amsterdam. 12-15 April 2000, will be another event to look forward to. The (official) deadline for paper proposals for this conference in May 1st, 1999 (see the announcement elsewhere in this newsletter).
