WELCOME ADDRESS



RESPONSIBLE HISTORY

Historians have duties and obligations. The nature and purpose of those duties and obligations is a rich topic of discussion for historians of history and history theorists alike. Moreover, it is an ethically, social and economically important topic, as the persecution of historians and the production of extremist or hate histories show.

It was for these two powerful reasons that the ICHTH responded to the call of the International Network for Theory of History for papers for its 2024 conference in Lisbon. We issued an open call for contributions, and were delighted with the response. We would like to thank all of you for alerting members and colleagues to this opportunity, and to the many people that came forward with proposals. The response highlights both the talent and the collegiality of ICHTH, and a shared interest in ensuring that histories should be good, fair, and just, and that historians are able to enjoy the benefits of freedom in the discharge of their duties and obligations. We are proud to support these endeavours.

The response also highlighted the rich range of topics and approaches that may be expressed under the heading of responsible history. It encompasses ancient and contemporary history, different approaches to evidence and methodologies, and the uses of histories in educational, social, political, economic and judicial contexts. This breadth highlights that responsibility is not just a matter for individual historians, and that the importance of the topic is not exhausted through an examination of professional codes of conduct.

Individuals have duties and obligations, but so do communities and organisations. Scaling our sense of responsible history to understand historical trends over long time spans and across the Globe, and to track the forms of theory—logic, ethics, metaphysics, epistemology—is timely and even pressing. So while we look forward to celebrating the individual contribution of panellists next year, we encourage members to help us to articulate social, system, and global level observations and recommendations.

I am particularly keen to learn more from colleagues as I continue work on machine and non-human historians. Luciano Floridi has argued in *The Ethics of Information* (2013) that artificial agents can be considered accountable, but not responsible. The more I look at the rapidly evolving story of artificial intelligence and machine learning, the more I am unsure about this. We are already living with the consequences of algorithms making recommendations on the basis of past data, and I think the time is overdue for AI to be seen as an historical discipline.

This is not a future or exotic topic. We have an opportunity—even duty or obligation—to support endeavours and systems that minimise harm. I am not just citing human harm here, but we are more and more of the thought that our work is interconnected with the health of the places in which we live, and our Globe. Responsible history is a big, and audacious topic, and we look forward to hearing more from you about it as we head to 2024.

COMMISSION NEWS

NAME OF THE COMMISSION

A memo from the Executive Committee to the Board enumerated the pros and cons of the current name of our Commission. The Board discussed the memo and decided to hold an internal poll to gain insight into whether there was a clear majority for another name than the current one to propose to the General Assembly. The poll, held in March and April 2023, showed the following picture: three Board members preferred the current name (International Commission for the History and Theory of Historiography); three preferred the name International Commission for the History and Theory of History; three preferred the first, pre-1995, name International Commission for Historiography; one preferred the name International Commission for Histories; one preferred a reversal of the current name (International Commission for the Theory and History of Historiography), and two abstained. The voting was accompanied by a rich e-mail correspondence defending or refuting the respective preferences and views. The poll showed no clear majority for any of the options, on the contrary opinions were quite fragmented. Under these circumstances, the Executive Committee decided not to pursue the matter further. It was resolved to leave the name as is.

2024 INTERNATIONAL PRIZE OF HISTORY

On 11 September 2023, the ICHTH Board submitted the candidacy of prof. dr. em. Frank Ankersmit, honorary member of the ICHTH, for the 2024 International Prize of History (a prize established by the International Committee of Historical Sciences). From the submission letter:

Professor Ankersmit's file speaks for itself to such degree that any attempt to embellish it with an elaborate endorsement letter would be merely adding a small flower to what is presently one of the richest gardens in the field of historical writing, and in particular in the philosophy of history, political theory, and intellectual history. When then President of the International Committee of Historical Sciences Jürgen Kocka had to introduce Frank Ankersmit to one of the most successful panels of the 21st CISH Congress in 2010, he observed: "Professor Ankersmit does not need an introduction, everybody knows him and his work." And so it is. Not only has he written an oeuvre that is as vast as it is innovative, he is quoted in scores of writings in and outside the historical profession globally and he himself and his work have become the subject of critical discussion in plenty of articles, books and PhD theses. Self-evidently, he has been a honorary member of our Commission for many years.

Under such circumstances of brilliance, it is not only a pleasure and an honor, but also a duty for the ICHTH to submit Professor Ankersmit's application for the Prize and to recommend it to the Jury in the most robust terms.

The Critical Global Studies Institute at Sogang University will host an international conference titled "National Megalomania and Imagined Ancient" from Nov 01 to Nov 3, 2023, at Sogang University in Seoul, South Korea. The conference consists of South Korean and Central European historians' collective effort to shed light on striking affinities in pathological ("megalomaniac") symptoms of the political unconscious and methodologies that are found in some (pseudo-) historiographies in East Asia and Central Europe. These affinities indicate the shared transnationality in the national on the side of the right-wingers' politics in both regions, which reminds a reader of the commonalities of East Asia and Eastern Europe in their experiences of modernity, transition from dictatorship to democracy, and (re)shaping of collective memories in Global Easts. Presentations at the conference would be later published in a book, National Megalomania and Imagined Ancient: Post-Cold War History in Central Europe and East Asia, from Central European University Press.
