WELCOME ADDRESS



ast year in this column I wrote about the importance of teaching historiography and historical theory and lamented that in North America it is not taken all that seriously (in contrast to other parts of the world). I also offered multiple definitions for what is meant by the term "historiography" and how we as Commission members might continue to promote its teaching.

In this column I want to address a theme that has been important to me, pedagogically, in the past few years, and that is helping students to understand the implications of the past for the present and vice versa. I do this principally in a course that I've taught both at the graduate-only and senior undergraduate level. It has the rather boringly open-ended title "History in the World". I try to keep it current by changing the reading list every year, and also dropping one topic and adding a new one

with every iteration. Every cohort of the class is asked at the conclusion of term to "vote one topic off the island" and suggest a topic that wasn't covered. Using that method, the course has transitioned over its 5 or 6 offerings like the proverbial ship replaced plank by plank till it's almost a new ship, but still the same ship.

The approach with the senior undergrads is a bit different than with the postgraduate version of the seminar. For one thing, I expect a good deal more reading and longer written assignments out of the graduate students. In addition to a longish research paper at the end of term, each grad student provides two book reviews, one on a shared book that is then discussed in class (a new feature this year arising from last year's class's exit comments), and a second on a book selected from a list I provide, with no more than one student assigned to each book. Over the years the shared-reviewed books have included Joan Wallach Scott's On the Judgment of History, Mark Donnelly and Claire Norton's Liberating History, and Jerome de Groot's *Double Helix History*. I'm running the course again this winter and will soon have to decide on the common book.

The undergraduate version of the course has somewhat different assignments. Most of the students come to it with little background in historiography (though I note with pleasure that the group I'm teaching this fall has some survivors of my 2nd year "introduction to historiography" class a couple of years ago—gluttons for punishment!) Instead of book reviews, they are shown a controversial video or interview and asked to comment on it as one assignment. In the second, we do a role-play exercise in which a fictional university has to wrestle with a naming controversy over a statue to a former benefactor found to have some skeletons in his closet. The students are given several weeks to prepare to play their roles. Needless to say this has proved quite fun in the past as the class members have to impersonate student

radicals (easy for some of them), university administrators, and anti-woke members of the public, crusty trustees, and so on. They write up their roles and what they learned from playing them subsequent to the final debate.

The conduct of classes varies a bit less between graduate and undergraduate versions of the course, in the sense that both are seminars and require students to take turn (in teams) a couple of times a term to introduce the readings with several questions for the class as a whole to discuss. In an ideal discussion, I have to intrude rarely to direct the traffic or provide some detail they may be missing. The day before I wrote a draft of this column I had to provide the undergraduate class with some background theory they were struggling with while they evaluated the heated debate between Hayden White and Arthur Marwick in the Journal of Contemporary History some three decades ago. The following week when we discussed the ethical and practical implications of DNA and genetic testing, and the issue of false claims to indigenous ancestry, I hardly had to intrude at all and even the quietest student in the class piped up with her views!

The graduate student discussions are a bit more focused on untangling some complex readings (I always start that course with Arjun Appadurai's brilliant 1981 essay "The Past as a Scarce Resource"). In both versions of the course, though, a typical week's readings will not all be strictly academic but will include "ripped from the headlines" current controversies as reflected in newspapers and magazines—for instance the fate of the Benin Bronzes as well as the Parthenon marbles is discussed.

In the undergraduate course, we begin with a discussion of several quotable remarks ranging from Orwell's "He who controls the past controls the present; he who controls the present controls the future" to William Faulkner's "The past isn't dead; it isn't even past" and Joyce's Stephen Daedalus wish to awake from the nightmare of history--which usually leads to a mention of Walter Benjamin's "Angel of History". (Recent

developments in rewriting and sanitizing the past in the United States have given me a lot more material to work with on many of these topics). Occasionally we will have visitors, for instance, Marnie Hughes-Warrington, who was with us in person for a week as a distinguished visitor and led the graduate version of the class last fall in an animated discussion on AI and History, the subject of her outstanding new book *Artificial Historians*.

Finally, we don't shy away from hard topics (Israeli vs Palestinian views of 1948 was a new topic last year with, of course, tempers running a bit high but discussion still civil). What strikes me most in teaching both versions of this course is just how engaged our students are and how much of an appetite they have to see the implications of various forms of the past on the present, its "haunting" quality, and the way present issues in turn change, sometimes radically, our perceptions of history. It's been an enormously fun course to teach, even when discussions get animated as (in the best editions of it) they often do.

You may remember that in January 2024 the ICHTH Board sent a unanimous letter of protest against the venue of the CISH Congress in Israel (see https://www.ichth.net/archive/29.pdf). You may agree with the ICHTH Board that the Israeli withdrawal now is the wisest, indeed the only possible, step in the face of that unfolding tragedy of epic proportions in the Gaza/Israel conflict.
